12/13/2024 Affidavit of Rian Waters

- 1) I never bought or sold drugs in California.
- 2) The defamatory statements in the Second Amended Complaint are exact quotes from Aidan Kearney's first edition "I am Turtleboy"
- 3) Kearney's harassment is the identified cause and stressor of my adjustment disorder. I have not been reasonably eating or sleeping because the court decisions approving of Kearney's actions cause preoccupation with the stressors and the consequences, which is causing a variety of health issues.
- 4) Aidan Kearney has numerous witness intimidation criminal charges in Norfolk Superior Court for harassment that is minor compared to what my witnesses faced.
- 5) After asking for case documents showing the cause of my injury and reviewing them, Edward K. Ryter, MD, of South Hadley, decided that he didn't want to be my doctor any longer.

- 6) On November 19th 2021, Aidan Kearney copied my Facebook account and used the account to threaten to rape and murder his own children.
- 7) Cristina Yakimowsky provided screenshots of Kearney's Facebook group chat showing that he orchestrated the November 19th fake threat conspiracy, and that he knew that I did not send the threats.
- 8) In the group chat Kearney said the goal of the threats was to stop me from filing in court cases.
- 9) On January 15th, 2022, Kearney extorted Yakimowsky saying if she didn't call him that he would go to her court hearing in February.
- 10) On February 17th, after following through with his extortion threat by showing the DA and judge that Yakimowsky asked for Kearney's help intimidating the victim in her criminal case, Kearney said presenting evidence against him is the stupidest thing anyone could do because everyone knows he is uncontrollably vindictive.
- 11) On June 23rd 2019, Kearney discussed this case, and then said if you participate in a court case against him that he will ruin your life, and that he would get sexual pleasure doing so.
- 12) On January 25th 2020, five days after this case was docketed in the Appeals court, Kearney showed pictures of me and my house and told his public shaming blog what my address is, and said the world would be better off with me dead.
- 13) On June 18th 2022 (12 days before a hearing for sanctions dealing with the November 19th conspiracy) Aidan Kearney hosted a video on YouTube titled "Ep #493 - Worcester Softball Mom | Easton Trump Store Attack | Drag Queen | Is Crissy Going to Jail?" The link

contains a timestamp, the bad parts start around 2:03:30, but it causes me too much distress to watch and find times.¹ In the video Kearney said;

- a. "I don't know why you thought this was a smart idea, Chrissy, because you know me, and you know what I do, and you know I'm not gonna rest, you know that right, like you own a business, I am speaking to Chrissy right now cause I know she's listening. So, you a business, you have couple kids or whatever, and a family and it's called Royal Thermal View, did you think I wasn't gonna make it like my mission to take all that away from you? Did you think that?"
- b. "I'm just going to do what I always do, I am going to remind you every f*cking day, when you're alone, and sad, and crying, that you were the dumbest fucking person, who made the biggest mistake of your life when you decided to f*** with me, me of all people, me the most vindictive cunt on the planet, and you're like I'm gonna go f*** with that guy. That's a mistake girl..."
- c. You've also lost your son, he's gone now, he will never look at you the same way, you're gonna be a estranged from him forever. Your own mother hates you, Cindy, she don't like you. Your, your business is going to severely suffer from this, when I contact every single one of your customers and let them know that -- and I'm gonna call every single one of your customers and let them know that any conversation that they have with you on the phone was likely recorded. Because that's what you are, you're a convicted wiretapper

and your lawyer has, you're gonna lose your lawyer now too, you are losing everyone, cause that's what I do to people, Chrissy, who fuck with me, and maliciously, I don't take it on the chin, I'm not one of those people that just moves on, I'm a vindictive cunt. And I'm not gonna stop, we're just beginning here. I'm not gonna stop destroying your life, just destroying it, like I am gonna take everything away from you that you love, I want you to feel as low as I did in early January when I found out that you betrayed me. I want you to feel that pain, and you're gonna feel it.”

d. “I will not stop until you beg for mercy, and then I'm going to do it twice as much, you're gonna feel the way I felt when I was in my garage when I wanted to kill myself.”

14 Today on December 13th 2024 I asked Aidan Kearney where he wanted me to serve him, (since he no longer lives at his house and he asked me not to send any more papers there,) **Kearney said he would not respond to the motion** and again asked me not to send him anything else. I said I would mail the papers to his house, and Kearney stated that I had just threatened to kill him. I responded saying obviously I hadn't, Kearney said “well I'm going to the police and I'm going to tell them you threatened me have fun in prison Rian.” And then he hung up.
